2. INSTRUCTIONS FOR USE

Remove eyebrow and eyelash makeup with a cotton pad impregnated with Brow and Lash Shampoo.

PRECAUTIONS:

- Avoid direct contact with the ocular mucosa: accidental contact is warned by not having carried out an irritation test on the ocular mucosa and verifying that it would not irritate it.
- Do not apply inside the eye: it is a product for exclusive use on the external surface, in this case, on the eyelashes.
- Not suitable for children under 12 years of age: the responsible person has considered that people under 12 years of age, due to their anatomical and risk characteristics, are not suitable for the use of this product.
- Not suitable for people with delicate eyes or with allergies: for this reason, the responsible person recommends
 trying the product on the forearm area first and suspending its use if irritation, redness, itching, inflammation
 occurs. If any symptoms persist, see a doctor.
- Do not use if you suffer from dry eye problems, eye infections or inflammation: the responsible person considers that this product is for cosmetic use only and that it should not be applied to surfaces with any type of eye pathology mentioned above.
